

**SCHOOL BUS TRANSPORTATION APPLICATION 2019-2020**

*(PLEASE USE ONLY ONE APPLICATION FORM PER FAMILY.)*

All students who wish to ride the bus **MUST** obtain a bus pass. Students in grades K-5 do not have to pay for the pass and students in grade 6 who live more than 2.0 miles from their school **DO NOT** have to pay a fee but all students must still obtain a pass; otherwise, the fee is **\$350 per student with a family cap of \$700**. Families may apply for a fee waiver based on financial hardship so that no student is denied bus transportation. See Financial Assistance check box below. All eligible students must fill out the application below. Please make the check payable to the City of Newton and write "Bus Fee" along with your child's name and school on the left hand corner of the check. **Please mail the application and check to the Transportation Office, Newton Public Schools, 100 Walnut Street, Newtonville, MA 02460-1398 by August 16th.** Abuse of the bus pass system or violation of the school system's rules of behavior will result in disciplinary action including suspension of transportation privileges and forfeiture of fees.

**Installment Plan:** Families may request to pay the fee in installments, but must pay at least 50% of the total fee by August 16th. Families will be billed for the balance of the fee payable by February 1st. All prior year balances must be paid in full in order to receive a bus pass for the new school year.  *I wish to apply for the installment option and have enclosed at least 50% of the total fee.*
